BILLS CURRENTLY BEFORE THE US CONGRESS: SOME WILL PREVENT TERRORISTS FROM ENTERING OUR COUNTRY SOME WILL KEEP OUR BORDERS OPEN TO THEM

There are so many bills in Congress dealing with secure borders that the situation is somewhat confusing. To a great extent this confusion is intentional. The anger over the endless flood of illegal aliens and the unknown terrorists and violent felons entering our country has reached a boiling point in many areas.

By now, so many Americans have been victims of crime, traffic accidents, increased health costs, schools in crisis, lost jobs and destroyed neighborhoods, all the result of uncontrolled illegal immigration that even the worst members of Congress cannot ignore the overwhelming majority who support secure borders.

Unfortunately, almost lost in the debate is the real threat of terrorism resulting from the ability of terrorists to hide among "ordinary" illegals as did the 9/11 hijackers. For example, the Sheriff of Hudspeth County, Texas (West Texas near El Paso) has in custody a suspected al Qaeda agent. The large news outlets have entirely ignored this incident, as they have ignored the widespread evidence of Middle Easterners illegally crossing the Mexican border during the last decade.

Evidently, to the NY Times, Washington Post, ABC, etc. this is not of major importance...until the next 9/11.

Nevertheless, because of the other horrors infliced on Americans by illegal immigration even people like Sen. John McCain and Ted Kennedy are now publicly acknowledging that our "borders are broken" and "something must be done."

Typically for them what they say must be done is to reward the 12 to 20 million illegals now in the country by giving them the right to stay in the US, pay a few hundred dollars and become citizens.

The Kennedy-McCain open borders politicians are introducing legislation they call "reform" but which is nothing more than the same old open borders nonsense.

Listed below are the bills that will actually protect our country from terrorists concealed among the millions of illegals, followed by those bills that will provide profit to a few while exposing the rest of the country to more terrorist acts.

BILLS THAT WILL HELP EXCLUDE TERRORISTS FROM THE U.S.

 HR 4313: TRUE Enforcement and Border Security Act of 2005 Introduced by Reps Duncan Hunter and Virgil Goode.

This is comprehensive legislation that deserves the support of every American concerned with preventing future terrorist acts. It does NOT grant amnesty to lawbreakers. 9/11 FSA has been asked by Rep. Hunter's office to write a lette endorsing this bill and we have agreed to do so.

Some of the things it does do:

- --Creates border fence from Pacific Ocean to Gulf of Mexico; Adds 8,000 new border patrol Adds 8,000 Border Patrol agents over 6 years in addition to the 10,000 added in the Intelligence Reform and Terrorism Prevention Act and adds,1,250 immigration investigators, 2,000 worksite investigators.--Appropriates five billion dollars for the above purposes alone
 - --Makes Defense Department equipment available for border patrol
 - --Adds 1,000 new DHS investigative personnel, and 500 trial attorneys over five years
- --Establishes new Assistant Attorney General for Immigration Enforcement within DOJ and adds 250 litigation attorneys, 250 U.S. attorneys, and 250 immigration judges over five years
- --Withholds State Criminal Aliens Assistance and funds from state or local agencies that willfully fail to share immigration information relating to the arrest of illegal aliens
 - --Requires NCIC listing of many illegal aliens
- --Requires DHS to take into custody within 72 hours illegal aliens detained by state/local law enforcement
- --Affirms state and local authority to investigate, identify, apprehend, arrest, detain, or transfer to federal custody illegal aliens
- --Confirms that it is unlawful for states to provide in-state tuition to illegal aliens unless the same benefit is provided to out-of-state citizens
- --Denies federal financial assistance, grants, reimbursements, or other financial assistance to post-secondary educational institutions that provide in-state tuition benefits to illegal aliens in violation of this provision
- --Restricts judicial review of visa revocations, regardless of whether the revocation forms the sole basis for removal.
- --Suspends the Visa Waiver Program until DHS certifies to Congress that: the automated entry-exit control system is implemented and functional;
 - --Eliminates the "visa lottery".
 - --Abolishes adult siblings and adult sons/daughters preference categories for issuing visas.
 - -- Denies citizenship to children of illegals
- --Requires employers to verify an applicant's eligibility to work by confirming with the SSA the individual's identity, social security number and, for non-citizens, authorization to work in the U.S. Enables employers to conduct verification either online, by telephone or through a card-reader system.
 - --Denies social security benefits for any work performed while a person was illegally in the US.
- S.2061: A bill to amend the Immigration and Nationality Act and other Act to provide for true enforcement and border security, and for other purposes.

 Sponsored by: Sens. Ben Nelson (Neb), Tom Coburn (Okla) and Jeff Sessions (Ala) This bill has many similar provisions to the True Enforcement Act, but is less comprehensive. Like the Hunter-Goode Bill it does not grant amnesty

THE FOLLOWING BILLS ARE BILLS GRANT AMNESTY

THEY ARE UNACCEPTABLE TO ANYONE WHO SUPPORTS SECURE

BORDERS. Recall that an amnesty was granted in 1986 and there was widespread fraud. Several of the men who later were involved in the first WTC bombing were given amnesty. The amnesty gave them the opportunity to reside in the US legally.

 S. 1438, Comprehensive Enforcement and Immigration Reform Act of 2005, Sponsored by Sens. Cornyn (Tex) and Kyl (Ariz) An amnesty bill packaged with some enforcement measures. • S.1033 Secure America and Orderly Immigration Act. Sponsored by Sens.

McCain and Kennedy. Typically for these two Senators, this bill is an attempt to mislead the American public. This is a pure amnesty bill that permits nearly all of the lawbreaking illegals in the US to buy US citizenship for one thousand dollars. It states specifically that it does NOT grant any additional authority to states and localities to enforce immigration law. The bill has nothing of value in the way of enforcement and through the mass amnesty that it offers it creates enormous incentive to further unlimited illegal immigration.
