**9/11 FAMILIES FOR A SECURE AMERICA
STATEMENT OF OPPOSITION TO AMNESTY FOR ILLEGAL ALIENS
AND ANY OTHER FORM OF "LEGALIZATION"**

- **Illegal Immigration Has Resulted Needless Deaths and Suffering by Americans**
- **Amnesty (whether or not camouflaged by terms such as "path to legalization") will result in more American deaths and suffering at the hands of criminal aliens.**
 - The 9/11 Commission stated the obvious: if terrorists cannot get into the United States, they cannot commit acts of terror on our territory. The same truth applies to all violent crimes committed by illegal aliens.
 - America's open borders have allowed terrorists and violent felons easy access to American victims.
 - Our members' suffering is irrefutable evidence of that fact.
- **GRANTING AMNESTY TO ILLEGAL ALIENS WILL INEVITABLY RESULT IN HUNDREDS OF THOUSANDS OF VIOLENT FELONS AND TERRORISTS BEING GIVEN NEW IDENTITIES THE RIGHT TO REMAIN IN AMERICA**
- **AMERICANS WILL DIE AS A RESULT**
 - Every illegal alien is a person whose true identity has never been verified by competent federal officials. Thus, any illegal alien may be a terrorist or violent felon. It is not possible to keep terrorists out of the United States without denying entry to all illegal aliens.
 - Illegal aliens who were given amnesty in 1986 participated in: the 1993 WTC attack (6 dead, 1000 injured); the shooting outside CIA headquarters (2 dead, 3 wounded); the plot to blow up NYC landmarks and tunnels.
 - All the terrorists who committed the 9/11 attacks would have been eligible for the current amnesty proposals.
 - Three of the "Ft. Dix Six" would have been eligible for the proposed amnesty.

**TO PREVENT FUTURE CRIMES BY FOREIGN TERRORISTS AND VIOLENT FELONS WE
STATE OUR GOALS:**

- **Illegal aliens must be denied "legalization."**
- **All illegals must be strongly encouraged to return home by denial of any and all benefits granted to citizens and legal residents other than emergency services.**
 - The massive number of illegal aliens present in the United States has caused the ending of interior enforcement of immigration law. The millions of illegals in our country acted as an 'ocean' which allowed the 9/11 terrorists to hide in plain sight and similarly provided cover for illegal alien felons.
 - There cannot be a real war on terrorism as long as the U.S. does not enforce its immigration laws against all would-be illegal entrants and illegals already in the country.
