**Bill to Mandate Statewide Enforcement of Immigration Law
Under Sec. 287g Introduced in NY State Assembly**

New York State Assemblyman Greg Ball at the request of 9/11 Families for a Secure America has introduced legislation that will mandate implementation of 287g (local enforcement of immigration law) throughout the State of New York. The bill AB 10593 and I've attached a copy of the official summary.

Among the provisions of the bill:

Every Sheriff's and Police Department and Department of Corrections to participate in immigration enforcement.

Release of convicted illegals only to ICE

Request for monthly list from ICE of sex offenders on the NYS list of registered sex offenders

Overrides local laws that prohibit participation in the listed programs.

Requires contractors doing business with the state to use the E-Verify program.

Requires notification of victims of identity theft.

Prohibits "Sanctuary city" laws.

For your information I've also attached the flyer about a seminar we are holding tomorrow 40 miles north of NYC for law enforcement and elected officials in the region.

The seminar results from the work of 9/11 FSA Director Ed Kowalski and Advisor Jim Staudenraus.

**New York State Assembly
A10593 Summary:**

SPONSOR Ball

Requires memo of understanding between attorney general and United States immigration and customs enforcement regarding criminal aliens.

TITLE OF BILL:

An act to amend the executive law, in relation to an agreement under the federal illegal immigration reform and immigrant responsibility act

regarding criminal aliens

PURPOSE OR GENERAL IDEA OF BILL:

Requires memo of understanding between attorney general and ICE regarding criminal aliens

SUMMARY OF SPECIFIC PROVISIONS:

The executive law is amended by adding a new section 844.

JUSTIFICATION:

1) Public safety - a fundamental responsibility of every elected official in New York State. While the vast majority of illegal immigrants are not, violent criminals, none have been subject to the Criminal Back-ground Checks required of lawful immigrants. Federal crime data from the Department of Justice shows that among all 50 States, New York spends more each year incarcerating Criminal Aliens than any State except California. In 2007, the taxpayers of New York spent \$165 Million incarcerating Criminal Aliens convicted of crimes committed here in New York. We can not continue to wait for Washington to address the vexing issue of illegal immigration.

This legislation is aimed directly at Criminal Aliens on our streets, and incarcerated within our State, and it will guarantee that deportable Criminal Aliens including sex offenders are never released into the public.

2) Protecting scarce State budget resources - holding the Federal Government responsible. New York's illegal alien population is costing the state's taxpayers more than \$4 billion per year for education, medical care and incarceration. The Federal government is in fact responsible for these costs. By requiring all vendors who do business with our State to comply with Federal immigration and Labor laws, we reward law abiding companies and ensure that lowest bidders are not cheating the system through the use of illegal alien labor.

This legislation is a common sense measure to recover from Washington more of New York`s growing costs of incarcerating Criminal Aliens, and protect New York taxpayers. 3) Give New York`s law enforcement professionals the tools they desperately need. Criminal Aliens residing in New York, including violent members of international drug gangs, document forgers and sexual predators, all use lax enforcement of Federal immigration laws to avoid capture and arrest.

This legislation will help create a seamless web of law enforcement within New York State, and it will give the men and women who patrol our streets and highways the training and cooperation with ICE that they must have to be effective.
