## **OUR GOAL AND HOW TO ACHIEVE IT**

### **OUR GOAL: AMERICA SECURE FROM DANGEROUS ILLEGAL ALIENS**

**AN AMERICA IN WHICH CITIZENS CAN ONCE AGAIN BE CONFIDENT THAT DANGEROUS ALIENS ARE NOT ALLOWED TO ENTER THE COUNTRY AND COMMIT ACTS OF VIOLENCE; WHETHER THESE ARE STREET CRIMES OR TERRORIST ACTS.**

Because every illegal alien is a person whose true identity has never been verified by competent federal officials, any illegal alien may be a terrorist or violent felon. It is not possible to keep terrorists out of the United States without denying entry to all illegal aliens.

Because the massive number of illegal aliens present in the United States has caused the ending of interior enforcement of immigration law the millions of illegals in our country acted as an 'ocean' which allowed the 9/11 terrorists to hide in plain sight.

Because there cannot be a real war on terrorism as long as the U.S. does not enforce its immigration laws against all would-be illegal entrants and those already in the country.

### **HOW TO ACHIEVE THIS GOAL: THE ESSENTIAL REFORMS**

#### **1. To Secure Our Borders**

- Assign troops to patrol the Mexican and Canadian borders and seaports to halt the entry of all 'ordinary' illegal immigrants and the unknown terrorists among them.
- Enforce existing federal law barring employment of illegal aliens. Employers who violate this law must be prosecuted and maximum penalties sought.
- Deny amnesty or legalization to illegal aliens and the unknown terrorists among them.
- Strip the State Department of all visa granting power, and transfer this authority to the Department of Homeland Security. (All employees involved in the issuance of visas must be subject to the Federal Tort Claims Act, subject to civil suit in damages by victims injured due to negligence in carrying out their obligations to screen visa applicants. This exposure to civil liability would be no more onerous than that is now imposed on Americans operating in the private sector.)
- Complete elimination of the Visa Waiver Program.
- Require all State and local law enforcement agencies that receive federal funding to deputize their officers to enforce immigration law and supporting legislation. Deny federal funds to those jurisdictions that officially or unofficially enforce "Sanctuary policies."
- Streamline the denaturalization process for those who obtained citizenship through fraud or deception or who commit terrorist acts in concert with foreign terrorist entities or governments.
- Ban federal recognition of "consular cards." Prohibit federally chartered banks from accepting them; prohibit acceptance of consular identification cards for any purpose by any jurisdiction or private agency that receives federal funds

- Full implementation of REAL ID to deny federal recognition of the drivers' licenses of states which do not require license applicants to prove they are legally present in the U.S.

## **2. To Eliminate Incentives to Illegal Immigration**

- End granting of citizenship to children born within the borders of the United States to illegal aliens;
- Ban of public benefits in any form to illegal aliens;
- Overhaul and simplify the current complex, unenforceable system of immigration laws.
- End "chain migration."
- Overturn Plyler v. Doe, to end provision of public education to illegal aliens.
- Require all hospitals that receive federal aid and which provide services to illegal aliens to report information about such patients to the Department of Homeland Security.
- End granting of FHA mortgage loans and any other form of loan guaranteed by any agency of the federal government to illegal aliens. Require proof of legal residency to establish eligibility.
- Rapidly deport incarcerated illegal aliens upon completion of their sentences; all costs of incarcerating illegal aliens incurred by entities receiving federal aid must be reported to the federal government which will make the information public.
- Deduct any costs incurred by United States by illegal aliens from the foreign aid of their home country.

## **3. To Reduce the Influence of Foreign Governments on Immigration Policy**

- Require all individuals as a condition of holding any elective or civil service position in the Federal government, to agree not to accept employment with a foreign government or business, or any entity controlled directly or indirectly by a foreign government, or accept a gift or thing of value from a foreign government or entity for twenty years after leaving government service or knowingly benefiting from a gift or thing of value given to a spouse for the same period. Provide for enforcement by "private attorneys general" on terms similar to provisions in environmental statutes.
- Prohibit all contact by Members of Congress or their staff from discussing any legislation, regulation or policy of the United States with any United States citizen who is employed by a foreign government as defined by the Foreign Agents Registration Act.
- Enforce provisions in existing treaties barring consuls and all other diplomats and employees from meddling in political affairs in the US. This to include lobbying of State and local officials, or aiding or abetting illegal immigration to the US. Establish a private cause of action by individuals against landlords of embassies and consulates who violate these provisions.
