

N.Y.CITY COUNCIL DEMANDS TERRORISTS BE ELIGIBLE
FOR U.S.DRIVERS' LICENSES (Just Like Mohammed Atta)

On December 21, 2005, New York's City Council presented a wonderful Christmas gift to terrorists and criminals around the world: it passed Resolution 1009 which demands that future would-be terrorists be allowed to obtain US drivers' licenses, the very same tools which played a critically important role in permitting the September 11 terrorists to carry out their plot. Wherever Islamic extremists are hiding, wannabe Mohammed Attas are marveling at the divine intervention that is the only possible reason the Council could be so stupid as to pass such a resolution.

Of course, the Council members did not openly admit they want to aid the next 9/11 terrorists; instead they used code in an attempt to conceal their real intent from the people who will be harmed by their action, that is, the people of the United States.

Here are extracts of the Council's Res. 1009: *"Resolution expressing continued opposition to the REAL ID Act of 2005 passed by Congress and signed by President Bush...Whereas, While the stated goal of the REAL ID Act of 2005 is to prevent terrorist attacks by disrupting terrorist travel, it contains numerous provisions that will hurt immigrants living and working nationwide...Whereas, The new law also imposes federal standards on drivers' licenses that... will prevent many immigrants from obtaining drivers' licenses. [T]o protect the livelihoods of millions of immigrants who must drive and might otherwise have to do so unlawfully; now, therefore, be it Resolved, That the Council of the City of New York urges New York State to opt out of implementing the law's provisions regarding issuance of driver's licenses to immigrants."*

Like any good code, the beauty of the Resolution' language is that it appears to have an entirely innocent meaning. . . until it's deciphered. For example: On December 7, 1941, the apparently harmless phrase "Climb Mount Niitaka" meant "Proceed with attack on Pearl Harbor" when decoded by the Japanese Imperial Navy. And so it is with Res.1009: on its face it appears harmless, but its true meaning is that Americans will die.

Recall that the September 11 terrorists used at least 35 authentic US-issued drivers' licenses issued under 19 names (and untold more under their other 346 aliases) to carry out their conspiracy to commit mass murder. Recall also that the independent 9/11 Commission described in detail in its Report and monograph on Terrorist Travel the crucial role that these licenses played in allowing the terrorists to rent cars, hotel rooms, and apartments, and to open bank accounts, credit card accounts and obtain all the other things they needed to plan, rehearse, finance and carry out their attacks. And on the morning of 9/11 these licenses, issued by Virginia, Florida, Maryland and California, allowed them to be waved past security and onto the planes they turned into guided missiles. These were among the reasons that on December 5, 2005 the former Commissioners specifically praised passage of REAL ID Act and said that "states' compliance must be monitored" as part of the campaign to stop terrorism.

The REAL ID Act, which the hundreds of members of 9/11 Families for a Secure America lobbied so hard to pass, simply encourages states to stop issuing licenses to ILLEGAL aliens. It is an essential anti-terrorism measure because **every** illegal alien is a person whose true identity is unknown. Thus **any** illegal alien may be a terrorist or violent felon in addition to being a violator of numerous federal laws governing immigration. Thus, states which issue licenses to illegals will inevitably be issuing them to the unknown terrorists among them.

Making terrorists eligible for drivers' licenses is the unexpressed goal of Res. 1009. This explains the need for the Council to resort to code. Instead of speaking in plain English and using the word "illegals" Council members attempt to conceal their true intent by saying they want to help "immigrants." But "Immigrants," (people who are legally in the US) are already eligible for licenses in all 50 states, so the only people who could possibly benefit from implementation of Res. 1009 are illegals.

In Res. 1009 the Council also said REAL ID must be sabotaged in order to *"protect the livelihoods of millions of immigrants who must drive and might otherwise have to do so unlawfully."* Decoded this means: "Millions of people show contempt for US law by sneaking into

the US to take away from citizens and legal immigrants; these lawbreakers want to drive to those jobs and we want to reward them for their illegal behavior by giving them licenses.”

Not content with concealment their goal the Council also provided false information about the Real ID Act. Res. 1009 states that *“The Congressional Budget Office has estimated that the implementation of the Real ID Act will cost [the individual states] \$100 million over five years...”* Here’s what the CBO really said in its Cost Estimate dated February 7, 2005: “CBO estimates that these additional requirements in H.R. 418 [the REAL ID Bill] would impose costs above those incurred under current law. Based on information from state representatives, CBO estimates that DHS would spend about \$20 million over the five-year period to reimburse states for the cost of complying with the legislation...”

In other words, the true cost of implementing REAL ID is \$20 million, not \$100 million, the cost is spread over five years, and the costs to the states will be reimbursed by the federal government. That’s four million a year for fifty states plus D.C. and territories. (To be sure, the cost is borne by federal taxpayers no matter which layer of government signs the checks, but the implication that cash strapped states are being terribly imposed on is simply a lie.)

The City Council also neglected to mention that thanks to the remarkable political courage shown by New York State Commissioner of Motor Vehicles Raymond Martinez, that state has fully implemented reforms throughout its DMV system and has created the most secure licensing system in the Nation. It is already be extremely difficult for any terrorist pretending to be a legal or illegal alien to obtain a license in New York. Those reforms are so thoroughly embedded in the DMV’s computer systems and regulatory framework that to remove them would actually cost the state considerable funds if it attempted to create the less secure system the Council demands. Meanwhile, the negligible costs of complying with REAL ID will be reimbursed by the Feds.

Clearly, saving money is not the real NY City Council agenda, kowtowing to the illegal alien lobby is.

So, why should anyone outside of New York City care if the Council, issues a demand that REAL ID be sabotaged?

Everyone should. This Resolution is just the exposed tip of a national effort by the Open Borders Combine to keep our Nation defenseless against terrorism for the purpose of allowing unfettered entry by illegal aliens. No one should think that this is just an event with strictly local implications.

The agents who persuaded the City Council to provide this Christmas gift to alQaeda, and who undoubtedly provided the false figures included in it, are the same agents who have been actively lobbying virtually every city, county, state and federal lawmaker, chief executive, mayor, rule maker, and administrator, to encourage illegal immigration.

Among those responsible for passage of Res. 1009 and its equivalents around the country are the forty-four Mexican consuls seeded throughout the US. These foreign agents are in essence unregistered, unregulated lobbyist/saboteurs for Mexico who, due to diplomatic immunity and the connivance of Pres. Bush and are immune from prosecution even while they openly violate treaties banning them from involvement in internal US politics. Mexico’s Consul in NY, Arturo Sarukhán actively lobbied for Res. 1009 and his 43 counterparts are lobbying in fifty states and hundreds of municipalities to obtain for illegal aliens all the rights enjoyed by US citizens and legal aliens.

Res. 1009 is nothing more than an attempt by Mexican officials to sacrifice American lives in order to continue the illegal alien racketeering which sends \$20 billion per year to that one corrupt nation alone.

Joined with the Mexican government in lobbying for its pro-alQaeda legislation are the usual organizations. The list includes Catholic Charities, Inc., most of whose client base and reason for being is continually replenished by illegal immigration. The immigration lawyers and the employers of illegals and their stable of puppet organizations, the US Chamber of Commerce, American Immigration Lawyers Assn, National Assoc. of Manufacturers, etc. Litigation racketeers including ACLU, and Southern Poverty Law Center. Ideological groups such as the US

Communist and socialist parties, Libertarians, the American Friends Service Committee, the National Immigration Forum.

At the very root of this effort to open America to more illegal immigration and the terrorist infiltration that is a part of it are the wealthy foundations and individuals providing the cash that drives the whole enterprise: George Soros, the Ford Foundation, the Carnegie Corporation, David Gellbaum (the man who bought the Sierra Club) and many others.

Thus, no American should think that NYC Council Resolution 1009 is just a local matter. It is one p[ie]ce of a many-part document of surrender that, to be made palatable to the American people must be published only in its coded form. In 1941, a three word coded message, "Climb Mt Niitaka," was sufficient to result in the deaths of nearly 2000 Americans at Pearl Harbor. NYC Council Res 1009 uses a lot more words, but that is necessary in an instrument of unconditional US surrender.

Res. 1009 was written so as to conceal its true meaning from Americans. But now, you know the code.
