### **DEFEAT Sen. Harry Reid's So-Called "Improving America's Security Act of 2007"**

*Bruce DeCell, Vice President of 9/11 Families for a Secure America, recently announced that 9/11 FSA opposes passage Sen. Harry Reid's S.4, the so-called Improving America's Security Act of 2007.*

*Mr. DeCell described S.4 as "Just another attempt to fool the American people into thinking the Congress and the President are serious about fighting terrorism. This bill, like the first bill that was described as a 9/11 Commissions recommendation implementation bill, is a fraud. Congress refuses to address the main gaps in American security: its wide open borders and the ease with which illegal aliens, and the unidentified violent felons and terrorists among them, can get authentic US drivers' licenses and other state-issued ID documents."*

*Peter Gadiel, 9/11 FSA president, said: "S4 simply continues the subterfuge begun with the 2004*

*Intelligence Reform and Terrorism Prevention Act. S. 4 merely creates a new alphabet soup of bureaucracies such as 'Fusion Centers' which are supposed to improve the 'information sharing environment,' a problem supposedly solved by the 2004 Act. Instead, it creates pork barrel programs such as the 'Homeland Security Information Sharing Fellows Program,' 'Urban Area Security Initiatives,' a new 'Office for the Prevention of Terrorism' and a Director of that Office. "*

*Joan Molinaro, 9/11 FSA Secretary, added that: "Congress continues to act as though our wide open borders and millions of "undocumented" (unknown) illegal aliens are not the main terrorist threat to the USA. The only mention S4 makes about our borders is to expand the Visa Waiver Program so that more millions of citizens of other nations can come to the US without even the formality of obtaining a visa." She added, "On top of that, the same Senators sponsoring this bill are supporting amnesty for millions of illegal aliens, among whom are unknown terrorists and violent felons. And these same Senators are in favor of repealing the REAL ID act in order to permit illegal aliens and terrorists to get US drivers' licenses and other ID documents.*

*Gadiel concluded: "Although a few 9/11 family members support S.4, 9/11 FSA believes no American should be fooled by politicians who exploit 9/11 when it suits them but refuse to take the actions that are essential to preventing terrorists from entering our country, namely, securing our borders and our identity documents."*
