

All 9/11 family members know that their love ones died because government failed to live up to its most basic obligation to its citizens...to protect them from foreign attack They know the government failed in the areas of foreign and domestic intelligence.

The 9/11 Commission state this a phrases a three year old could understand: If terrorists cannot enter the US they can't commit acts of terror in this country. Yet, this IS beyond the understanding of politicians like.....

Now, the illegal alien lobby makes much of the fact the terrorists all had visas to enter the US.

Thus, say the ACLU, the immigration lawyers: The terrorists weren't illegal aliens" and, according to the twisted logic of these lawyers, since the terrorists were "Legal" there's no reason to stop illegal immigration."

But the coalition of open borders profiteers that successfully lobbied congress to get the State Department to grant visas to anybody and everybody is the SAME coalition that ended effective patrol of our borders and ended enforcement of immigration law INSIDE the borders of the USA.

So..it is true that all the 9/11 killers had visas. It's also true not one was eligible to enter the US and not one visa was properly granted But it's also true beyond shadow of doubt that the presence of 10 million to 20 million illegals in eh US proves the killers didn't need to bother with visas...they could have done what millions of others have done and just walked in.

Also, once there killers were here, that population of millions of illegals provided an ocean of concealment which allowed the killers to operate freely without interference from law enforcement or civilians while they leisurely planned, financed, rehearsed and carried out their murders.

After 9/11 Congress, always ready to evade responsibility blamed the INS and the Border Patrol. But these agencies were or are merely creatures of the Congress and the Executive Branches. Their existence their policies, their regulations, their funding, their assets, their jurisdiction and their staffing were all subject to the direct and absolute control of the President and Congress.

Thus, the attempt by elected officials to shift the blame to anonymous bureaucrats was both dishonest and cowardly.

Consistent with their policy of evasion many members of Congress have continued to claim that the obvious and essential reforms that would reduce the threat “cannot” be enacted into law.

Members like Nancy Pelosi claim that putting troops on our borders would “endanger our freedom.” Yet to say this is to say that having open borders where anyone, including terrorists, can freely enter our country somehow PROTECTS our freedom. Yet

The Ted Kennedy’s and John McCain’s say that deputizing 700,000 state and local peace officers to enforce immigration law would “undermine law enforcement.” Yet to say this is to claim that having a total of two thousand federal officers assigned to finding the 10 or 20 million illegals now in our country (which is the true state of our “immigration enforcement” today “) somehow HELPS maintain respect for the law and is not a threat to peaceful citizens.

The Larry Craig’s and the Richard Lugar’s say we MUST grant amnesty to millions of people who entered our country illegally because somehow, having the FBI do millions of background checks on people from all the remotest and most dangerous parts of the globe will not detract from its ability to fight terrorism.

In truth, politicians of both parties who oppose secure borders have made individual political calculations and decided that what is necessary for the security of our country might, in the short run, cost them the support of the open borders profiteers.

I wonder how many Americans know that under current federal law “mere membership” is NOT sufficient grounds to deny a visa to an applicant. This privilege for terrorists was inserted into the law by Ted Kennedy and Barney Frank of Massachusetts.

Rep James Sensenbrenner’s Real ID Act would reverse this. “Mere membership” in AlQaeda WOULD result in denial of visas to terrorists.

Real ID passed the House 261 to 161 in a bi-partisan vote, but Joe Lieberman, Hillary Clinton, Lamar Alexander and other oppose the Real ID Act. Apparently, it’s okay with them if current law stands and terrorists continue to get visas.

The 9/11 Commission said that all but one of the mass murderers had authentic US drivers' licenses, maybe 35, maybe 63, but no one knows. The Commission did establish that the terrorists used 364 aliases, and the Commission's statement that the terrorists had "only 35" is likely a massive understatement, as those or the numbers they held under the names they used on 9/11.

Those drivers' licenses were the "valid I.D.s" that gave them access to all the goods and services they needed to plan, rehearse, finance and carry out their murders. These were the "valid IDs" that enabled them to open bank accounts, transfer funds, get credit cards, rent apartments, rent hotel rooms, rent cars, buy flight lessons. These were the IDs that allowed them to blend in.

And on the morning of 9/11 these were the IDs that allowed them to board the aircraft they used as weapons of mass murders.

Real ID would discourage that practice, **without creating a national I.D.** Yet, Senators, Lieberman, Sununu, Durbin and others oppose Real ID.

I wonder if the voters of CT < NH < ILL know that their Senators oppose legislation that will make it harder for terrorists to get this essential terrorists' tool.

Remember that phrase: "illegal aliens and the unknown terrorists among them."

EVERY illegal alien is a person whose true identity is unknown. Thus ANY illegal may be a terrorist or criminal, and states which issue license to illegals will **inevitably** be giving licenses to terrorists.

But that's not a concern to the Ron Wydens, the Chuck Hagels, the Patrick Leahys of the Senate, for they don't want to upset the US Chamber of Commerce, the immigration lawyer, LaRaza or Home Depot.
