

-MY Thanks to **Robb Pearson** - Founder, ProAmerica Society and to **Mayor Donald Cresitello**, of Morristown for permitting me to speak today.

-It's my belief that **ALL Americans** are indebted to Mayor Cresitello, because he's an elected official who is setting standard that all others should follow.

Mayor Cresitello is a man who, by having the police of his city participate in solving the crisis of illegal immigration has shown that HE understands the **purpose** of American government.

That purpose is set down for all of us to read in the Preamble of the U.S. Constitution:

"We the people of the United States, in order to form a more perfect union, **establish justice, insure domestic tranquility, provide for the common defense, promote the general welfare,** and secure the blessings of liberty to ourselves **and our posterity**, do ordain and establish this Constitution for the United States of America."

That sentence summarizes the reason our government exists: justice, domestic tranquility, the common defense, the general welfare.

Remember, that every elected official and bureaucrat from the President and Congress to the local canine officer draws his authority from our Constitution and must act for the purposes

Mayor Cresitello understands this. That is the reason he has made his city's police force a part of the immigration enforcement effort.

HE understands that without full and complete enforcement of immigration law we do NOT have justice. We do NOT have domestic tranquility; there is no common defense and the general welfare degenerates into general chaos.

Mayor Cresitello understands and acts to further the purposes of our Constitution while Pres. George Bush, Sen. Frank Lautenberg, Sen. Robert Menendez, Sen. John McCain show nothing but contempt for the security and lives of the American people by their refusal to enforce our immigration laws.

DO NOT FORGET THAT Every illegal alien is a person whose true identity has never been established by a competent federal official

Thus, **ANY** illegal alien is a person who may be a terrorist or violent felon.

AND many are.

The proof of that statement is Ed Kowalski's niece, my son. 3000 dead of 9/11 and thousands of dead, raped, killed in DUI, since 9/11.

The Constitution **ALSO** says: "The United States... shall protect each of [the States] against invasion;"

The Constitution did **NOT** say the President and Congress "**MAY**" protect the States against invasion it said they "**SHALL**."

In other words, a President, or any member of Congress who does not protect this country from invasion is in violation of his authority under the Constitution.

Today we have a President who refuses to carry out his obligations to the people of this country: He not only refuses to protect us from foreign invasion he justifies it. He wants to give amnesty to the millions who have invaded us.

And he is joined in this violation of the fundamental laws of the Nation by the likes of Senators , Schumer, Menendez, Lautenberg, McCain, Hillary Clinton and many of the rest of the members of the Senate and House and Governors like Corzine, Mayors like Bloomberg of NYC.

It is the refusal of these federal officials to live up to the obligations imposed on them by the Constution that make it necessary for Mayor Cresitello to act instead.

Now, the people who are attacking Mayor Cresitello are doing so because he wants to enforce immigration laws and because they WANT the 20 million lawbreaking illegals in the US to be rewarded for their criminal offenses with the greatest gift our government can bestow: amnesty and the right to become an American citizen.

But we have already had experience with amnesties

--Some of those who got amnesty later participated in the 1993 attack on the World Trade Center, killing 6 wounding a thousand.

--One of those amnestied later shot five people outside CIA headquarters, killing two.

--Some of those amnestied participated in a plot to blow up NYC bridges, tunnels and landmarks. That plot was thankfully thwarted by police, but the potential deaths were in the tens of thousands.

We know of these crimes committed by amnestied illegals because they grabbed the headlines. But how many other Americans have died, been raped, stabbed, beaten, shot by other illegals in crimes that did NOT make the front pages. We will never know.

No one here knows the name Elizabeth Butler, but she is as important as my son. She, not an illegal alien, a lawbreaker is part of the "posterity" that the Founders wrote our Constitution for!

Although we cannot with certainty know how many Americans have died or suffered because of the Clinton, Specter, Bush, Kyl open borders policies we CAN say with certainty that **many have died.**

Remember this: Every illegal is, as the ACLU, LaRaza, Chamber of Commerce, et al. like to say "undocumented."

What does "undocumented" mean?

It means that EVERY illegal alien is a person whose true identity is UNKNOWN. And that means that ANY illegal may be the next Mohammed Atta, the next serial murderer like the Angel Ramirez, the "RAILROAD KILLER." We just don't know which ones.

And that means when we give amnesty to the 20 million illegals now in this country, we WILL be granting amnesty to untold numbers of violent men and women who WILL kill and injure and unknown number of Americans.

The open borders lobby relentlessly speaks of the romantic past. But the world is not the place it was in 1870, 1900. Many, many conditions have changed. **Most important among those changes is that our government no longer cares who gets into our country.** Let me provide a personal perspective on that point.

My father was born in Germany in 1906. He was Jewish and an active anti-Nazi. My mother was a German Protestant who had married him in violation of Germany's "Racial Purity" laws. She left Germany for the last time literally 24 hours before the Gestapo came to arrest her. My father was marked for death by Hitler's goons. In 1940 he arrived in the United States officially classified as a "stateless person." However, his status as a refugee was conditional, with permanent status only being granted after a thorough investigation. He used to tell me "Before I was permitted to remain in the US the FBI practically looked under the fillings in my teeth to make sure that I wasn't a German agent."

Yet, my father said he was happy that the FBI examined him so closely. "I didn't want German agents in the US anymore than FDR did. I wanted to be safe." My father was proud that he passed the test, and felt safe because he knew his government was carefully screening every person who wanted to immigrate to this wonderful country.

How sadly ironic is it that his grandson, my son, was murdered on 9/11/2001 because the government of the United States had abandoned the practice of carefully examining those who wish to come to our country, and the Bush-Kennedy-Specter amnesty will result in many more millions of criminal aliens from all parts of the earth winning the right to stay in the USA without any effective investigation of their possible violent or terrorist backgrounds.

AS president of 9/11 Families for a Secure America it has been my painful duty to meet hundreds of people who have lost loved ones in the 9/11 attacks or to murders committed on the streets of our nation. I've met people who have themselves been victims of violent acts committed by illegals; people who survived that violence but whose lives are shattered forever.

I ask myself: What kind of man is George Bush that he will lift not a finger to prevent these crimes. What kind of men and women are Sen. Menendez, Lautenberg, Clinton who by not demanding enforcement of our border law have permitted the murders, rapes, gang violence, drunk driver murders that are plaguing America.

I do not hesitate to say it: Many of the highest officials of our Nation, by their inaction and defiance of their Constitutional duties have brought to this country exactly what the Constitution demands that they PREVENT: domestic chaos, violence and the collapse of the common defense. And thus they have on their hands the blood of the victims of the crimes committed by illegal aliens.

My son cannot speak. Elizabeth Butler cannot speak. Thousands of others cannot speak. Only their surviving loved ones, like Ed Kowalski and I remain to speak for them BUT Bush, Menendez, Lautenberg...they refuse to listen.

Mayor Cresitello, has demonstrated that through us, he has heard the voices of our murdered loved ones as they plead: "stop the slaughter."
