#### The Truth about the REAL ID Act and DHS Regs.

REAL ID would create a "national ID"

There will be no "national ID." Only your same old license

REAL ID would infringe on States' Rights"

States remain free to do what they wish, and issue licenses to illegal aliens. The only difference is that if a state continues to issue to illegals and terrorists, their licenses will not be recognized at federal facilities.

It would require you to carry your license,  
at all times

REAL ID and DHS regulations do **NOT** require you to carry your license except when you're driving a car on a public road.

It would allow police officers to "demand your  
papers" whenever they liked

As always you will only need to carry your license when driving your car on a public road. REAL ID and the DHS regulations do **NOT** allow police officers to "demand your papers," unless of course you are involved in a traffic stop, or are questioned in relation to a crime. In other

words there's no requirement to identify yourself to police in any circumstance not already covered by tradition and law.

---

It would require or authorize states to obtain Personal information about you not related to your ability to drive.

Do **NOT** require or authorize states to obtain personal information about you not related to your ability to drive.

It would authorize states to obtain information about your credit history, blood type, health history, gun ownership, education, your travels outside the country, employment, club memberships, or political involvement.

Does **NOT** authorize states to obtain information about your bank records, health records, gun ownership, education, employment or other personal information or other non driving information.

It would require including such information on the magnetic strip on the back of the license and in the states' DMV databases.

REAL ID licenses need only contain the following information: expiration date, bearer's name, issue date, date of birth, gender, address, and a unique identification number. (but not a social security number). This is LESS information than may be on your current license. Less information is needed because the photograph on your licenses is digitized (translated into a digital formula that is as unique to you as your fingerprint. No one can copy it.)

---

Homeland Security Department could issue rules requiring microchips in licenses and these chips would contain personal information.

The REAL ID Act does not authorize RFID chips. The DHS regulations specifically recommend AGAINST chips, saying it is not "an appropriate technology" for drivers licenses.

---

REAL ID would cause inconvenience by making people wait for hours or days for their licenses

Over 90% of Americans will have all the documents they need and get their licenses with no delay. A.. few people may encounter some problems. Those of us who have lost loved ones in 9/11 think that if a small percentage of us have to wait a few days to get a drivers license, this slight inconvenience is a small price to pay to prevent another 9/11 and more mass murder by terrorists. After obtaining your first REAL ID compliant license you will be able to renew by mail.

---

It would increase identity theft because state databases would be interlinked and REAL ID licenses would have RFID chips that could be read from several feet away.

REAL ID mandates heightened security requirements for all state DMV databases. There has never before a minimum security standard for DMV record keeping. Your personal records will be safer than ever before.

---

REAL ID would not prevent terrorism.

Do you actually believe that barring illegal aliens to obtain authentic US drivers licenses under assumed names WON'T reduce terrorism?

It would impose huge costs on states for implementation,

Experience in New York State and other states(which already verify the true identity of applicants) proves that cost savings resulting from reduction of welfare fraud, social security fraud,

REAL ID was "forced" through Congress without hearings.

There was extensive debate in both houses of Congress and there were hearings in the House. In the Senate, Joe Lieberman, John McCain and other supporters of open borders prevented hearings from being held.

## **WHY IS REAL ID ESSENTIAL TO THE NATION'S AND YOUR INDIVIDUAL SECURITY**

### **A. THE US DRIVERS LICENSE: ESSENTIAL TERRORIST TOOL**

The terrorists who murdered 3000 Americans on September 11, 2001 possessed *at least* 35 authentic US drivers licenses issued by five states. (35 licenses is the number they possessed in the 19 names that the Commission concludes were their real names. No one has attempted to discover how many licenses they may have possessed under the 345 other aliases they used.)

The independent 9/11 Commission concluded driver's licenses enabled the terrorists to obtain all the goods and services they needed to plan, rehearse, finance and carry out their conspiracy, e.g. rent cars, rent apartments, open bank accounts, transfer money from the Middle East, get credit cards, buy airline tickets, etc. On the morning of 9/11, the killers used their US licenses to breeze past security at airline gates and board the planes they turned into guided missiles.

Because US driver's licenses a key terrorist tool on 9/11 the five states that issued them licenses bear some responsibility for the 'success' of that conspiracy.

### **B. A DOZEN STATES ARE STILL OFFER DRIVERS LICENSES TO ILLEGAL ALIENS, THUS GIVING FUTURE TERRORISTS THE SAME ACCESS TO LICENSES AS MOHAMMED ATTA AND HIS CO-CONSPIRATORS ENJOYED.\_**

*Every* illegal alien is a person whose true identity is unknown, ("undocumented") meaning *no one has ever verified his identity*. Thus, any illegal alien can be a terrorist or a violent felon. Thus, all states which grant licenses to illegals are inevitably providing legitimate I.D. to people who intend to harm US citizens.

States that license illegals do so because of massive lobbying by left wing groups such as the ACLU, ethnic pressure groups such as the National Council of La Raza (The Race) and employer groups which profit from cheap illegal labor.
